



Attitude of University Student's towards Sports: A Study

The interior consistency coefficients for the scale are 0.86 for the main factor, 0.77 for the subsequent factor and 0.76 for the third factor, with a co-productive of 0.89 for the entire scale. As per the unwavering quality investigation of the examination, the dependability coefficients are 0.81 for the principal factor, 0.72 for the subsequent factor and 0.85 for the third factor, with a coefficient of 0.87 for the entire scale.
